City Attorney Janelle Combs addressed the commission regarding Ordinance 6501. She explained aspects of the ordinance and addressed questions that had been asked prior to the meeting.

Commissioner Marquardt stated that he is not in favor of the ordinance as it is drafted. He believes the discussion needs to expand to include others in the community including the Bismarck Public School District.

Commissioner Splonskowski stated that he cannot support the ordinance and believed that the community would further be divided if the ordinance were to be approved.

Commissioner Zenker stated that he cannot support the ordinance as drafted and stated that the discussion needs to start at home with families and teach children how to respect others.

Commissioner Guy noted that 24 community organizations provided letters of support for the ordinance and she noted that in addition to an ordinance addressing hate crimes, outreach programs, and working with the faith community to help families address treating others humanely in the home would go a long way to strengthen the community.

Commissioner Splonskowski made a motion to deny the ordinance, Commissioner Zenker seconded.

Upon a roll call vote Commissioners Zenker, Splonskowski, Marquardt, and Mayor Bakken voted aye. Commissioner Guy voted nay. M/C.

Commissioner Splonskowski motioned to approve the request as presented. Commissioner Zenker seconded the motion.

City Engineer, Gabe Schell, requested the approval of a resolution receiving bids and ordering the preparation of the Engineer's Statement and a resolution awarding the contract for projects SI 565 and SE 581.

Commissioner Zenker motioned to approve the low bid submitted by Strata Corporation in the amount of \$1,084,579.59. Commissioner Splonskowski seconded the motion.
