Call To Order

Chair Vannett called the meeting to order at 5:20 PM.

Roll Call

HRC Mission

### 1. Approval Of Meeting Minutes

Chair Vannett called for the consideration of the July 18, 2022, meeting minutes.

Motion: Darcy Andahl motioned to approve the minutes of the July 18, 2022, meeting as presented. Thea Jorgensen seconded the motion, and it was unanimously approved, with committee members in attendance voting in favor of the motion.

### 1. Hosted Events

- 20th Anniversary of the HRC
  - The group discussed having a party on Saturday, October 22, 2022, from 1:00 PM to 3:00 PM at the Bismarck Veterans Memorial Public Library. The party will celebrate the 20th Anniversary of the HRC. The general consensus of the committee is to invite past committee members, Humanitarian Award recipients, City Commission members, and other organizations that align with the HRC's mission. The group intends to provide light refreshments. The committee agreed to develop a program and finalize the details at the September 19, 2022 meeting. City Administration will create an invitation for the committee to review and distribute.

### 2. Partnered Events

Mary Van Sickle with Dakota Media Access attended the meeting to discuss options for film screenings and possible programming to raise awareness of the HRC's mission. The group agreed to develop a podcast program focusing on public conversations supporting the HRC's mission. Ms. Van Sickle suggested that the group create a list of topics, a name for the program, a monthly schedule for recording, and a minimum of six episodes to start. The goal would be to have one new program each month. The format would involve two HRC members and a guest expert related to each month's topic. The group will have Ms. Van Sickle back at the October or November meetings to share ideas and receive feedback about moving forward with the podcast.
