



## Bismarck Animal Advisory Board

### Call To Order

Vice-Chairman Sundstrom called the meeting to order at 10:00 AM.

### Roll Call

#### 1. Approval Of Minutes

#### 2. Proposed Ordinance Changes To Allow For The Keeping Of Backyard Chickens
