# MEETING OF THE BOARD OF CITY COMMISSION

2. Consider the approval of the minutes.

Commissioner Marquardt moved to approve the minutes as presented. Commissioner Splonskowski seconded the motion.

7. Public hearing on a new Class M Catering Liquor License for Harvest LLC.

No member of the public appeared for comment.

Commissioner Marquardt moved to approve the new license as presented. Commissioner Splonskowski seconded the motion.

Upon a roll call vote, all voted aye. M/C.

8. Public hearing on Ordinance 6450, regarding Competitive Bidding Required.

No member of the public appeared for comment.

Commissioner Guy moved to approve the ordinance as presented. Commissioner Zenker seconded the motion.

Upon a roll call vote, all voted aye. M/C.

Consider the request from the Community Development Department to present information on the City of Bismarck's involvement in the National Flood Insurance Program and the Community Rating System Program.

At the February 23, 2021 City Commission Meeting, the Commission requested the Department gather additional information on the National Flood Insurance Program and the Community Rating System (CRS) and present it to the Commission, in regards to the development of a temporary moratorium for the Misty Waters Subdivisions.

Community Development Director Ben Ehreth presented the information to the Commission. The information included a history of flood insurance, the City's current flood plain ordinance and details about the City's participation in the CRS program.

No motion was made for this item.

10. Consider the request from the Community Development Department for a Moratorium for Floodplain Development Permits associated with LOMR-F Applications for single, two-family and multi-family lots adjacent to Misty Waters Bay within Misty Waters Subdivision.

This item was tabled at the February 23<sup>rd</sup> meeting upon requesting the information presented in Item #9 and several other questions associated with the plat including the history, information on requests for the LOMR-Fs and how staff has handled these requests in the past. Director Ehreth explained the department received another request for a LOMR-F, and stated the department desired a moratorium to pause development on Bay lots to give the department additional time to assess the current ordinance before granting the request. He said that not supporting the MOA we would need to consult with Attorney Combs. A change in the PUD Ordinance would require a hearing and then go back to the Planning and Zoning Commission for approval.

Commissioner Zenker moved to deny a moratorium on the Bay lots. Commissioner Splonskowski seconded the motion. Upon a roll call vote, all voted aye. M/C.

11. Consider the request from the Engineering Department for Street Improvement District No. 541 - Request to hear insufficiency of protests on resolution of necessity.

Commissioner Zenker moved to approve the request as presented. Commissioner Guy seconded the motion.

Upon a roll call vote, all voted ave. M/C.

12. Consider the request from the Engineering Department for Street Improvement District No. 544 - Request to hear insufficiency of protests on resolution of necessity.

Commissioner Marquardt moved to approve the request as presented. Commissioner Splonskowski seconded the motion.

Upon a roll call vote, all voted aye. M/C.

13. Receive an update on the Bismarck Comprehensive Plan.

Community Development Department staff began working on the plan in early winter. The Comprehensive Plan will be used in many jurisdictions across the country as the guiding document for future growth and development of the physical, social, and economic environment of a community. Bismarck's plan was a collaborated effort of the City, County, the Park and School Districts, and highlights the City's growth, land use, transportation, natural resources, economy, health and more.

The Commission will receive more updates as the plan is developed.

No motion was made for this item.

14. Consider the request from the Administration Department for direction on a new Class E Beer-Only On/Off Sale license.

Commissioner Guy moved to approve the release of an additional license and put it out for bid. Commissioner Zenker seconded the motion.

Upon a roll call vote, all voted aye. M/C.

15. Receive an update from the Budget Committee regarding possible funding options for the Bismarck-Burleigh Public Health Department and Police Department plan for future facilities.

At the January 27, 2021 Special City Commission Meeting, the board moved to allow the departments and consultant, Leo A. Daley, to work with the Budget Committee to pursue funding for these projects and directed the City to begin exploring the options for purchasing a greenfield site for a new location for the Police Department. Please reference the minutes from that meeting to view the full list of space needs options the board recommended Leo A. Daley to explore.

Budget Committee representative Commissioner Marquardt stated the committee concluded funding for the future facilities would result in either a mill levy or a sales tax increase. Finance Director Dmitriy Chernyak presented some space needs financing options based on the estimated costs from the consultant.

The Commission discussed issuing a 1/4 cent sale tax, that would go before voters in June 2022. This tax would assist in funding the space needs project and an additional fire station. If supported by voters, the tax would sunset once the projects are paid off. Using sales tax to pay for the project was preferred by the board, as they could pay for the location without raising the property tax mill levy. Commissioner Guy stated Bismarck residents are not the only individuals benefiting from the services of the departments expanding.

Commissioner Zenker moved to begin looking at options for purchasing a piece of property to relocate the Police Department and bring the properties back to board to assess how much they need to take out of reserves to pay for the property.

Upon a roll call vote, all voted aye. M/C.

## Other Business

Mayor Bakken thanked the Chamber EDC for facilitating discussions throughout the 2021 Legislative Session with Bismarck-Mandan Legislators. Commissioner Guy reiterated Mayor Bakken's thanks and extended it to the Legislators that participated.

The Mayor also thanked Boy Scout Troop 122 for attending and presenting the Pledge of Allegiance at the meeting.
