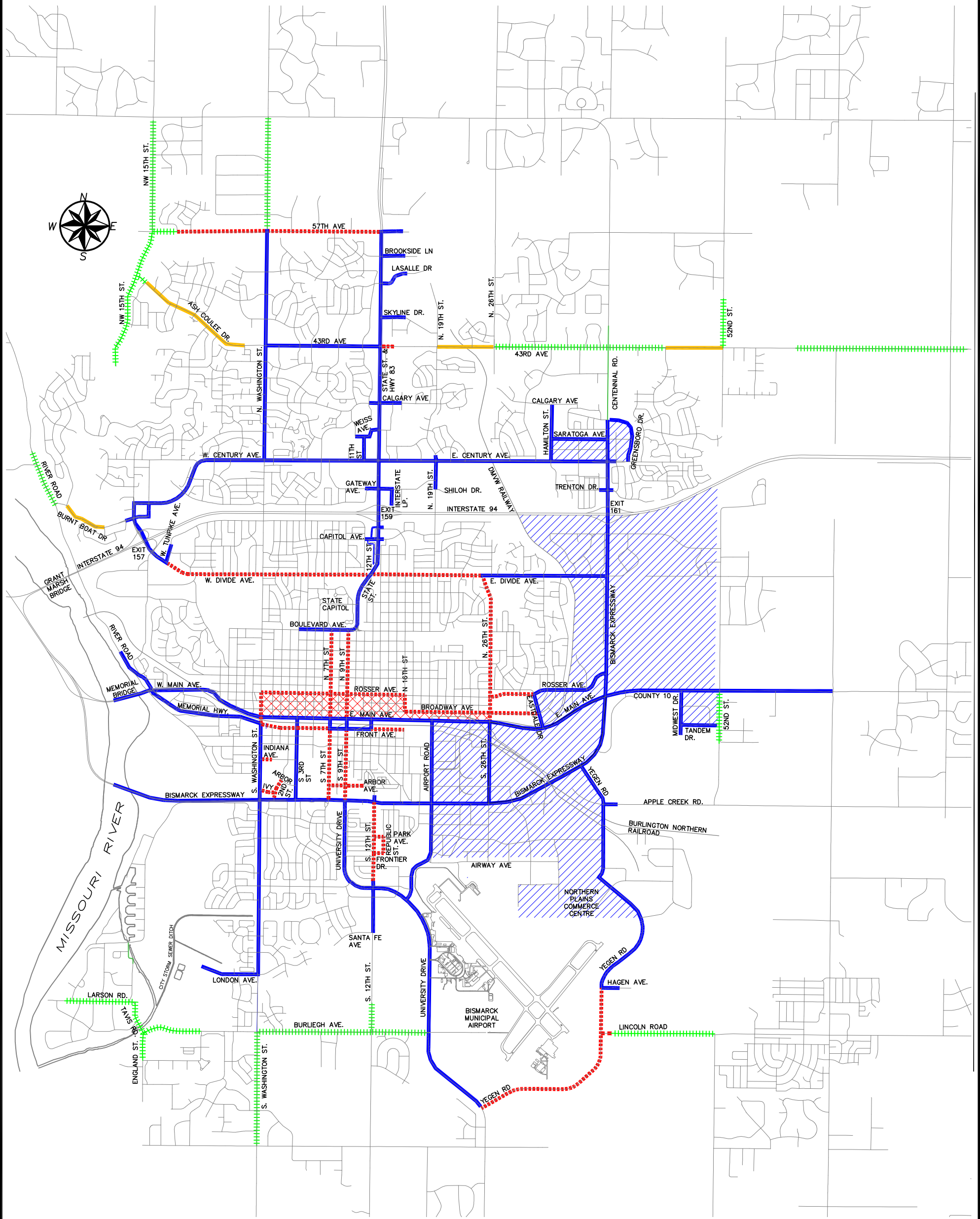

2021 SPRING LOAD RESTRICTIONS CITY OF BISMARCK

Load restrictions will be in effect on all paved and hard-surfaced streets and alleys in the City of Bismarck beginning at **7:00 a.m. on Tuesday, March 09, 2021** until further notice.

No City of Bismarck load restrictions will be in effect on Interstate 94. Interstate load limits are controlled by state and federal regulations.

The Following Streets are Restricted by Legal Weights: All streets in an area bounded by and including Century Ave. on the south, Saratoga Ave. on the north, Centennial Road on the east and Hamilton St. on the west; all streets in an area bounded by and including Greensboro Dr. on the north and east, Centennial Rd. on the west, and up to but not including Century Ave. on the south; all streets in an area bounded by Interstate 94 on the north, the DMVW Railroad on the west, by Rosser Ave. on the south, and by Bismarck Expy. on the east; all streets in an area bounded by Bismarck Expy. on the west, Interstate 94 on the north, County Highway 10 on the south, and by but not including 52nd St. on the east; County Highway 10 from Bismarck Expy. to 66th St; all streets in an area bounded by and including Midwest Dr. on the west, County Highway 10 on the north, Tandam Dr. on the south and 52nd St. on the east; all streets in an area bounded by and including Rosser Ave. on the north, Eastdale Dr. on the west, Main Ave. on the south and Bismarck Expy. on the east; all streets in an area bounded by and including Airport Rd. on the west, Main Ave. on the north, by but not including Airway Ave. on the south, and by Bismarck Expy/Yegen Rd. on the east; All streets in Northern Plains Commerce Centre Subdivision. Yegen Rd. from Airway Ave. to Hagen Ave. State St. from Blvd Ave. north to 57th Ave; Centennial Rd. from Interstate 94 north to Greensboro Dr.; 19th St. from 200 feet north of Century Ave. to Interstate 94.; Clydesdale Dr. from Century Ave. to Burnt Boat Dr.; Burnt Boat Dr. from Grandview Ln. to Clydesdale Dr.; Divide Ave. from Tyler Parkway to Turnpike Ave. and from 26th St. to Bismarck Expy; Turnpike Ave. from Divide Ave. to 750 feet north and east; Interstate Ave. from Gateway Ave. to Interstate Loop; West portion of Interstate Loop; 12th St. from Interchange Ave. south to State St. and from University. Dr. to Santa Fe Ave.; Interchange Ave. from State St. to 250 feet east.; Capitol Ave. from 12th St. to 14th St.; All of University. Dr. 12th St. from Bismarck Expy. to 300 feet north; Washington St. from Front Ave. to London Ave and from Century Ave to 57th Ave; 7th St., 9th St., and 12th St. from Main Ave. to Front Ave.; Front Ave. from 7th St. to 12th St.; 26th St. from Bismarck Expy. to Airway Ave.; Yegen Road from Bismarck Expy. to Hagen Ave.; All of Hagen Ave.; Century Ave. from Tyler Parkway to Yorktown Dr.; Main Ave. from the Memorial Bridge east to 66th Street; all of Airport Road, Bismarck Expy and London Ave.; Trenton Dr. from Norfolk Street to Berkshire Dr.; all of Weiss Ave.; 11th Street from Weiss Ave. to Century Ave.; Blvd. Ave. from 3rd Street to State Street; 3rd Street from Main Ave. to Bismarck Expy; Memorial Highway from Main Ave. south and east to Washington St.; Fraine Barracks Road; River Road from Fraine Barracks Rd. to 1300 feet north; Calgary Ave. from Lockport St. to St. Lawrence St; Skyline Dr. from State St. to 15th Street; LaSalle Dr. from State St. to 1200 feet east; Brookside Lane from HWY 83 to 500 feet east; 57th Ave. from HWY 83 to 500 feet east; 43rd Ave. from State St. to Washington St.

"7-Ton" Load Restrictions will be in effect on the following streets: All streets in an area bounded by and including Rosser Ave. on the north, Front Ave. on the south, Washington St. on the west, 16th Str. on the east; all streets except Main Ave. in an area bounded by and including Broadway Ave. on the north, Main Ave. on the south, 16th Street on the west, and 26th Street on the east; 7th St. and 9th S. from Bismarck Expy. to Front Ave. and from Main Ave. to Blvd. Ave.; Indiana Ave. from Washington St. 300 feet east; Ivy Ave from Washington St. to 2nd street; 2nd street from Bismarck Expressway to Arbor Ave.; Rosser Ave. from 26th Street to Eastdale Dr.; 26th Street from Main Ave. to Divide Ave.; Broadway Ave from 26th St. to Eastdale Dr.; Arbor Ave. from 7th St. to 400 feet east of 12th St.; 12th St. from Bismarck Expy. south to University Dr.; Park Ave. from 12th St. to Republic St.; Frontier Dr. from 12th St. to Republic St.; Republic St. from Frontier Dr. to Park Ave.; Front Ave. from Washington St. to 7th St. and from 12th St. to 16th St.; Divide Ave. from Turnpike Ave to 26th St.; Yegen Rd. from Hagen Ave. to ND 1804.; Lincoln Rd. from Yegen Rd. to 175' east of Yegen Rd.; 57th Ave. from State St. to Crested Butte Rd

"6-Ton" Load Restrictions will be in effect on all other streets in the City of Bismarck.

"20,000" lbs. Gross Weight Load Restrictions will be in effect on 43 Avenue from 19th Street to 26th Street and from Roosevelt Dr. to 52nd St.: Ash Coulee Dr. from Ash Coulee Water Tower to NW 15th St.; Burnt Boat Dr. from Clairmont Road to Broadview Lane.
